Re: Recommendation to add a resolution to the August 6, 2018 Board Agenda to place referendum question for \$195 million in building bonds on the November, 2018 election ballot.

History

The District created a Facility Master Plan (FMP) in 2012 that was largely focused on infrastructure. The goal of the FMP was to set a strategic direction for maintaining aging buildings. The FMP did not address whether the buildings were well suited to adapt to changing instructional programs or how space should be utilized for the collaborative nature of modern day education.

During the 2016-17 school year, on my recommendation and approved by the Board, the District engaged architectural firm Wight and Company to more fully review and provide information on the condition of the District's mechanical, electrical and plumbing systems and to review and provide information on the instructional and other spaces within the schools. Wight presented its findings, which were discussed at length at several of the Board's Buildings and Grounds task force meetings. During this process, proposed renovations at each school were carefully reviewed with an eye toward fiscal responsibility and scaled back substantially.

Community Input

The Board incorporated community engagement as a crucial component of the updated Proposed FMP. A Community Task Force task force of 40 citizens met four times from February to June, 2018. Task Force members represented varying viewpoints within all three District 207 High School communities. This task force toured each of the three buildings as part of their meetings.

During the first meeting, the task force was presented with a description of the FMP review process and was presented with the work performed by the District, in conjunction with Wight, to date including: a building priorities list, surveys results from students and staff, and information regarding other school districts that District 207 and Wight representatives visited.

At the second meeting, Wight provided information on two possible renovation options. One option was a more comprehensive model to address the majority of major needs previously identified. The other option was a scaled-back model that eliminated many of those needs. Both options included \$82 million in essential infrastructure needs. This information included the potential costs and the impact on taxpayers related to issuing bonds to pay for the work.

The task force discussed both options and decided that the comprehensive model (the \$195 million bond plan) should be presented to the public at community outreach meetings; in addition, they decided survey information on both options should be sought from taxpayers.

Following the recommendations of the Task Force, the District held two meetings in each school, as well as at several feeder schools in addition to other community meetings. At each of those meetings, the updated Potential FMP was presented. Two surveys were conducted by a professional consultant that specializes in polling. One was a mail survey sent to nearly 45,000 district households. The other was a scientific phone survey.

The phone survey was a statistically valid survey in which respondents mirrored the makeup of voters in terms of age and other key demographic variables. Phone survey results indicated that 58% of the respondents would definitely or probably approve a more comprehensive \$195 million bond measure if it were on the ballot with 31% of the respondents indicating they definitely or probably would not approve it. The mail survey, which was not scientific, showed a split of opinion with relation to approval or rejection of the more comprehensive \$195 million bond measure, with 48% indicating they would not support the ballot question and 44% indicating they would support it.

The survey results were shared at the third task force meeting. The Task Force was advised by the consultants that scientific phone survey results have been shown to be the most reliable in these processes. The task force broke into small groups to discuss the information and formulate a recommendation to the Superintendent. Each group recommended the more comprehensive \$195 million bond measure. Some expressed that the less comprehensive approach eliminated many of the instructional improvements that they believed were necessary following the several month information gathering process.

At the fourth meeting, the task force broke into small groups again. The administration wanted to provide another opportunity for feedback from members who had been unable to attend the third meeting and make sure that the more comprehensive \$195 million bond measure was the recommendation. The groups affirmed that the \$195 million bond measure was their recommendation.

In June 2018, the updated Proposed FMP was presented to the Board. This 200-plus page document also was provided to the public on the district website.

Superintendent Recommendation

Updating and modernizing our buildings is a need I've identified consistently over the years in discussions with Board members, with the Community Advisory Council, as well as with other community members and groups. The two most essential reasons to consider updating and modernizing are:

1. Changes are needed to provide students with a secure environment that is more conducive to contemporary teaching and learning. Our schools were all built in the early to mid 20th century in the industrial school model that was designed to sort and select students; today's ideal school model is designed to support every student to be his or her best. What we are doing in District 207 is progressive, and few high schools in America have evolved to incorporate better teaching and learning practices than we have created. This requires different spaces to achieve our goals fully. From a functional standpoint we have areas such as entrance and egress that do not meet today's higher standard for school security. Our cafeterias are still original to the days when we served single hot lunches, a practice decades out of

- date. Additionally, there are many areas in our schools that require improvement. Further, with our significant improvements in the level of personal service to each student in academics, social and emotional needs and college and career strategies, the need to have space designed to meet our current practice is essential to helping us continue to serve each student at the highest level possible. This work is at the forefront of the best work being done in these arenas and the facilities should support it rather than being a barrier to achieving that goal.
- 2. It has been nearly 50 years since we sought to make substantial improvements with community support, resulting in our school facilities not being on par with neighboring districts. Within the North Cook and nearby Lake County areas that include fellow Central Suburban League member high schools, District 207's total facilities are easily the furthest behind in terms of quality and design due to the roughly 50 years that the District has waited to ask taxpayers to support updating the buildings. I believe this is a "quality of community" issue that is directly related to our long-term community sustainability. As someone who has been a community member for 14 years in the District and a parent of two District 207 graduates, almost without exception when I have gotten feedback about our school buildings it is in the form of comments about how our facilities do not compare well to those of our conference members. At some point we have to consider this facilities question as a community, just as former generations did before us. These schools are OURS and they exist to serve our community's students currently and in the future.

Delaying the question puts the District further behind.

Further delaying this important community question not only delays providing solutions, but it also increases the cost and scope of future work that must be completed. We have proven to be good stewards of our buildings, and significant upgrades to those building to insure their continued ability to serve effectively as essential learning hubs in our communities is a continuation of that stewardship. We are called to lead on this issue. It is our job to share with our citizens clear information about the building needs and allow them to make an informed decision through the democratic process. Based upon the comprehensive process District 207 has followed, especially incorporating the valuable input from a cross section of taxpayers who served on the Task Force, and given the significant needs of our school buildings, I am recommending the Board adopt a resolution at our August 6, 2018 meeting to place a \$195 million bond issue on the ballot for the November 6, 2018 election.

Dear Mary:

In accordance with your instructions, we have prepared and are enclosing a suggested form of Election Resolution for the above-referenced matter. In that regard, we call your attention to the following election procedures:

- We understand that the Election Resolution may be considered by the Board of Education (the "Board") on August 6, 2018.
- If adopted by the Board, a certified copy of the Election Resolution must be filed with the Cook County Clerk (the "County Clerk") on or before Wednesday, August 29, 2018. We would be happy to assist the District with the filing.
- 3. Notice of the proposition to be submitted at the election (the "Notice") must be published by the County Clerk not earlier than Friday, September 7, 2018, and not after Friday, October 26, 2018, in a newspaper having general circulation in the District.
- The Notice must also be posted not later than Friday, October 26, 2018, at the 4. principal office of the County Clerk.
- Additionally, the Notice must be posted not later than Friday, October 26, 2018, 5. at the principal office of the District.
- 6. Please note that the Notice referred to in the preceding paragraphs of this letter must be in the form set forth in the Election Resolution.

7. The wording of the Official Ballot (the "Ballot") is also set forth in the Election Resolution; the Ballot must be prepared by the County Clerk in accordance with the Election Code.

We would like to review proofs of the Notice and Ballot prior to publication or printing.

- 8. The results of the election must be canvassed by the County Clerk within 21 days after the election. The County Clerk will then transmit a signed copy or original duplicate of the completed abstract of votes and proclamation of results by facsimile, email or other electronic means to the State Board of Elections.
- 9. The federal Voting Rights Act requires Election-related materials in Cook County to be translated into a language other than English. The District and the County Clerk are responsible for ensuring the accuracy of the translation of any election-related materials, and any error in any translation could void the Election results. Based upon past experience, we expect that the County Clerk will engage a professional translation service on behalf of the District and all other governmental units with public questions on the November 6, 2018 ballot.

The President announced that the Board of Education would next consider the adoption of a resolution providing for and requiring the submission of the proposition of issuing School Building Bonds to the voters of the District at the general election to be held on November 6, 2018.

Whereupon Member ______ presented and the Secretary read by title a resolution as follows, a copy of which was provided to each member of the Board of Education prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION providing for and requiring the submission of the proposition of issuing \$195,000,000 School Building Bonds to the voters of Township High School District Number 207, Cook County, Illinois, at the general election to be held on the 6th day of November, 2018.

WHEREAS, the Board of Education (the "School Board") of Township High School District Number 207, Cook County, Illinois (the "District"), has considered the existing school facilities and the improvements and extensions necessary to be made thereto in order that the same will adequately serve the educational needs of the District; and

WHEREAS, the School Board does hereby find and determine that it is necessary and in the best interests of the District that the School Board be authorized to improve the sites of, build and equip additions to and alter, repair and equip existing buildings, including, without limitation, constructing security improvements, increasing accessibility to comply with the Americans with Disabilities Act, replacing electrical, plumbing and mechanical systems, renovating classrooms and labs, improving the Library Media Center and renovating special education spaces (collectively, the "*Project*") at an estimated cost of \$195,000,000; and

WHEREAS, the School Board does hereby find and determine that the Project is needed to provide a quality educational program; and

WHEREAS, the School Board does hereby further find and determine that there are insufficient funds on hand and available to pay the costs of the Project; and

WHEREAS, before the School Board can provide the Project and borrow money and issue bonds for such purpose, a proposition therefor (the "*Proposition*") must be submitted to the voters

of the District and be approved by a majority of the voters of the District voting on the Proposition at an election to be held in and for the District; and

WHEREAS, the School Board deems it advisable, necessary and in the best interests of the District that the Proposition be submitted to the voters of the District at an election to be held and conducted in accordance with the general election law:

Now, Therefore, Be It and It Is Hereby Resolved by the Board of Education of Township High School District Number 207, Cook County, Illinois, as follows:

Section 1. Incorporation of Preambles. The School Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Need for Project. It is necessary and in the best interests of the District that the School Board be authorized to provide the Project, and that it is necessary and in the best interests of the District that money be borrowed and in evidence thereof bonds of the District be issued therefor to the amount of \$195,000,000.

Section 3. Submission to Voters. The Proposition shall be submitted to the voters of the District in accordance with the general election law at the general election to be held on Tuesday, the 6th day of November, 2018, between the hours of 6:00 o'clock A.M. and 7:00 o'clock P.M. on said day (the "Election").

Section 4. Voting Precincts and Polling Places. The Election shall be held in the voting precincts and at the polling places established by the County Board (the "County Board") of The County of Cook, Illinois (the "County"), for voters of the District at the Election.

Section 5. Election Notice. The County Clerk of the County (the "County Clerk") shall give notice of the Election, including the Spanish, Chinese and Asian Indian translations thereof as deemed by the County Clerk to be required by law (the "Notice"), in accordance with the general election law by (i) publishing the Notice once not more than 60 nor less than 10 days prior to the date of the Election in a local, community newspaper having general circulation in the District, and (ii) posting a copy of the Notice at least 10 days before the date of the Election at the principal office of the County Clerk.

Section 6. Local Notice. The Secretary of the School Board shall post a copy of the Notice at the principal office of the District.

Section 7. Form of Notice. The Notice shall appear over the name or title of the County Clerk and shall be substantially in the following form:

NOTICE IS HEREBY GIVEN that at the general election to be held on Tuesday, the 6th day of November, 2018, the following proposition will be submitted to the voters of Maine Township High School District Number 207, Cook County, Illinois:

Shall the Board of Education of Maine Township High School District Number 207, Cook County, Illinois, improve the sites of, build and equip additions to and alter, repair and equip existing buildings, including, without limitation, constructing security improvements, increasing accessibility to comply with the Americans with Disabilities Act, replacing electrical, plumbing and mechanical systems, renovating classrooms and labs, improving the Library Media Center and renovating special education spaces, and issue bonds of said School District to the amount of \$195,000,000 for the purpose of paying the costs thereof?

The polls at the election will be open at 6:00 o'clock A.M. and will continue to be open until 7:00 o'clock P.M. of that day.
