Enclosed is our bid based on your specifications and we acknowledge the general conditions, instructions to bidders, and other bid documents.

Our bid is based on increasing your district bus driver wages with a 6-hour guarantee of \$28.00 - \$30.00 per hour depending on experience plus benefits.

Safeway 12 months ago changed our minimum hours per day for all yellow school bus drivers to 6 hours from 4 hours guaranteed, which has significantly improved our ability to supply qualified school bus drivers.

All vehicles are equipped with "Synovia" GPS – accessible by your transportation department.

Dispatching/Terminal is located at our facility at 1030 S. Milwaukee Ave, Wheeling, IL.

We currently have approximately 40+ extra drivers and are supplying them to Oswego School District #308, Palatine #15, Lake Zurich #95, and Fox Lake #114.







**AMENDMENT TO THE SPECIAL EDUCATION BUS TRANSPORTATION SERVICES
AGREEMENT BETWEEN
THE BOARD OF EDUCATION OF MAINE TOWNSHIP
HIGH SCHOOL DISTRICT 207 AND SAFEWAY TRANSPORTATION SERVICES**

In consideration of the promises, covenants, terms, and conditions set forth in this agreement (the "Amendment") the Board of Education of Maine Township High School District No. 207, Cook County, Illinois (the "School District"), and Safeway Transportation Services Corp. ("Safeway"), hereby agree as follows:

I. Background.

A. The School District and Safeway entered into an Agreement for Special Education Bus Transportation Services, based on Safeway's April 7, 2023 bid, and approved by the Board on May 1, 2023 (the "Agreement"), regarding special education bus transportation services.

B. Safeway has proposed implementing a price adjustment to the daily AM/PM school bus route rates for services provided to the District as outlined in the Agreement by increasing these rates to \$505.60 per route per day, effective January 1, 2026.

C. The rate of this price increase is based on the volatility of fuel prices; competitive wages and benefits required to attract and retain drivers and aides; the rising costs of vehicle maintenance, repairs and replacement parts; and the substantial increases in liability and insurance premiums.

D. The parties agree that it is in their collective best interest to increase the rates for bus route services provided to the District.

II. **Rate Increase.** Effective January 1, 2026, the rates for individual AM/PM school bus routes shall be five hundred and five dollars and sixty cents (\$505.60) per day, this rate to remain in effect through the term of the Agreement which concludes on June 30, 2026. Safeway

further commits to providing all services outlined in the Agreement through the conclusion of the Agreement term which ends on June 30, 2026.

III. Effect of Termination. If Safeway terminates the Agreement with the District or the District terminates the Agreement for cause before June 30, 2026, Safeway shall assume all costs the District incurs to obtain a new bus service including, but not limited to, additional costs to paid to the new provider, required leases, vehicle acquisition costs, and related legal fees.

IV. Relationship to the Agreement. All other terms and conditions of the Agreement shall remain in full force and effect. If there is a conflict between the terms of this Amendment and the Agreement, the terms of the Amendment shall control.

V. Effective Date. This Amendment shall be deemed dated and become effective on the date the last of the parties signs as set forth below the signature of their duly authorized representative.
